
FUND DESCRIPTION


LATEST QUARTERLY COMMENTARY

LionGuard Canadian Small Cap Equities Fund ("Fund") materially outperformed the S&P/TSX Small Cap Index ("Benchmark") during the third quarter of 2019. During this period, Fund returned 1.88% as compared to Benchmark at -1.86%.

The sectors with the highest value added were Health Care and Financials with a large part of the benefits coming from stock selection. Sectors where the Fund lagged the Benchmark were Real Estate and Consumer Discretionary with the costs coming mainly from a difference in allocation and to a lesser extent from stock selection. Our largest relative contributors were Major Drilling (MDI), Altus Group (AIF) and Equitable (EQB). At the same time, being overweight in Total Energy (TOT) and not owning Eldorado Gold (ELD), First Majestics Silver Corp. (FR) and Silvercorp Metals (SVM) has cost us relative to the Benchmark.
