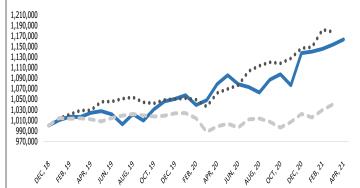
### STRATEGY DESCRIPTION

LionGuard Market Neutral Strategy ("Strategy") had a positive net return of 1.42% during the first guarter of 2021. The sector with the biggest positive contribution was Technology while the sector with the largest negative contribution was Consumer Discretionary. Our largest contributors during the period were our long positions in DIRTT Environmental Solutions, Sangoma Technologies and Donnelley Financial Solution. Our biggest detractors included our longs in Dye & Durham and Kar Auction Services.
