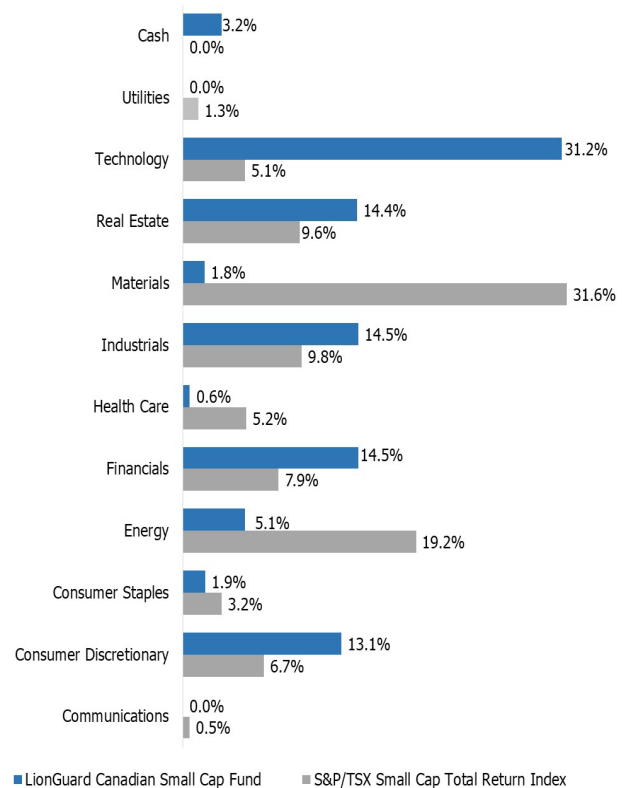
FUND DESCRIPTION

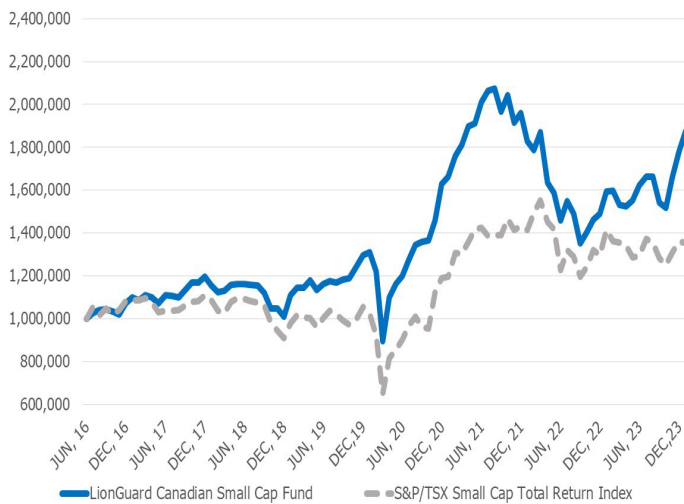

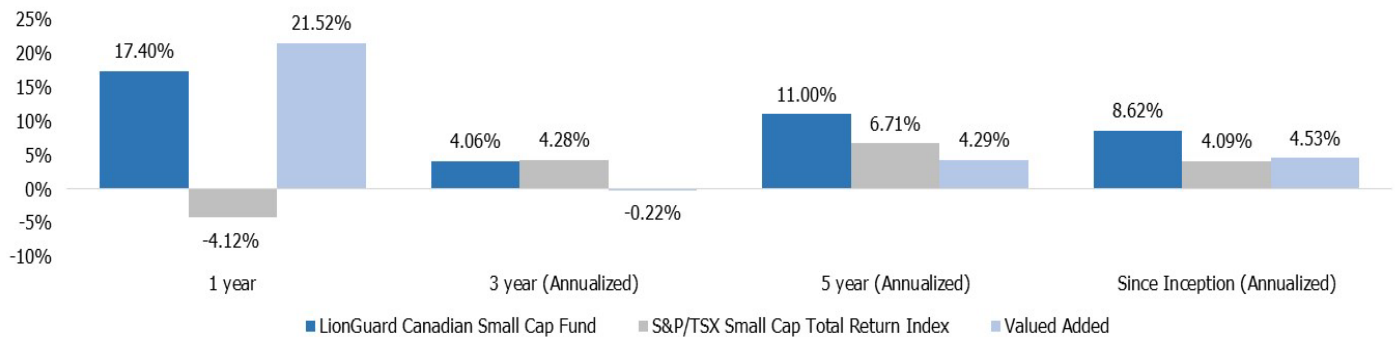
