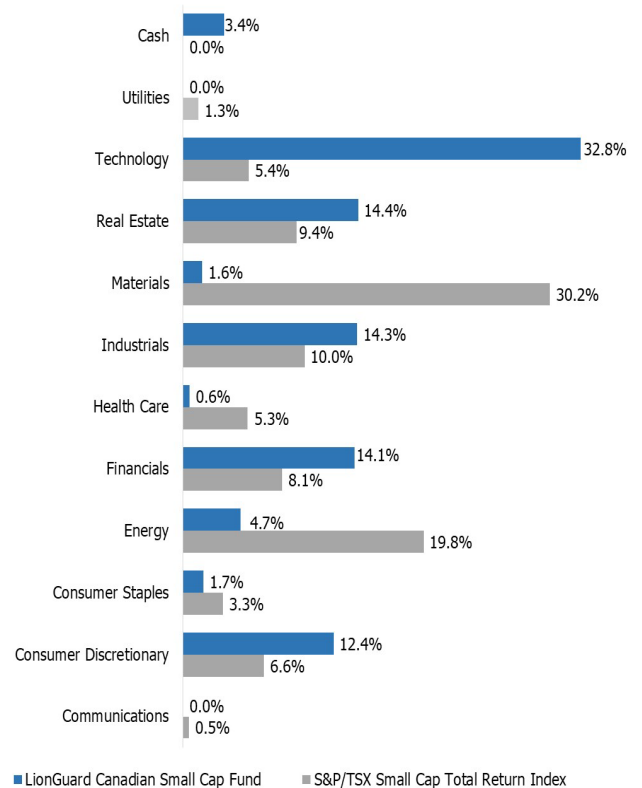
FUND DESCRIPTION

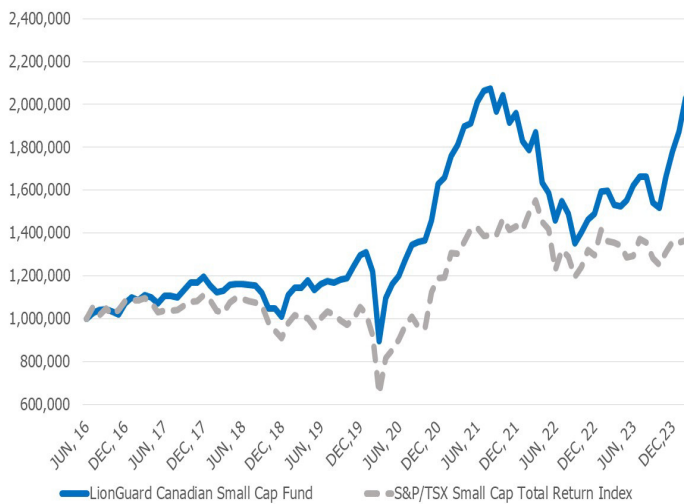

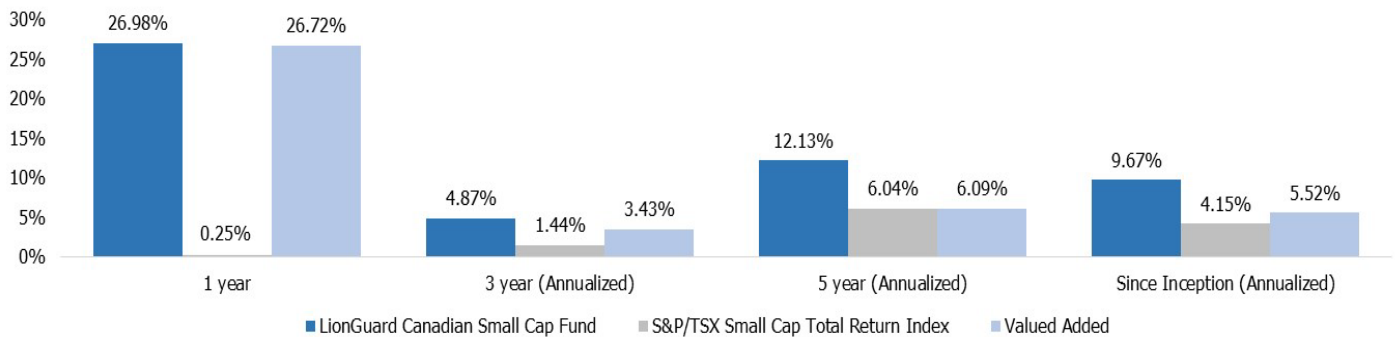
