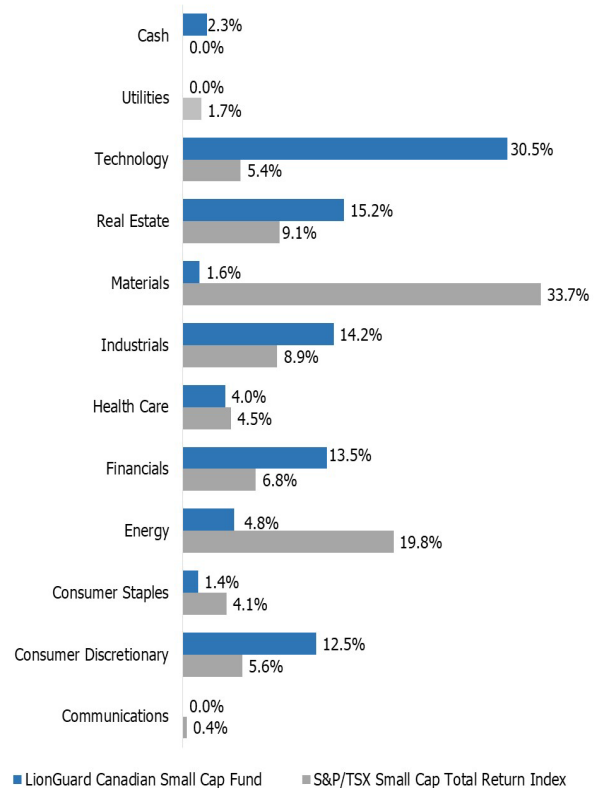
FUND DESCRIPTION

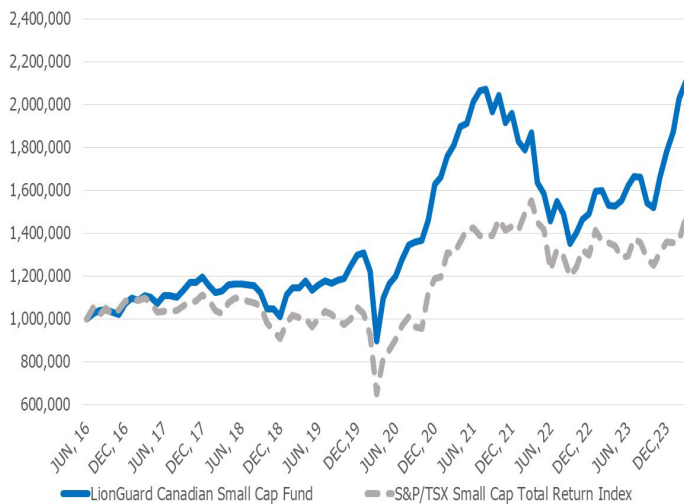

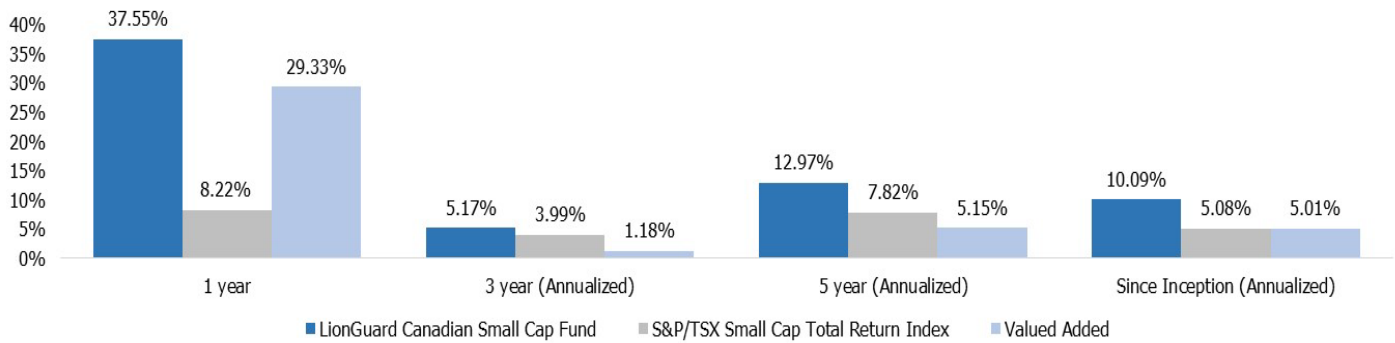
