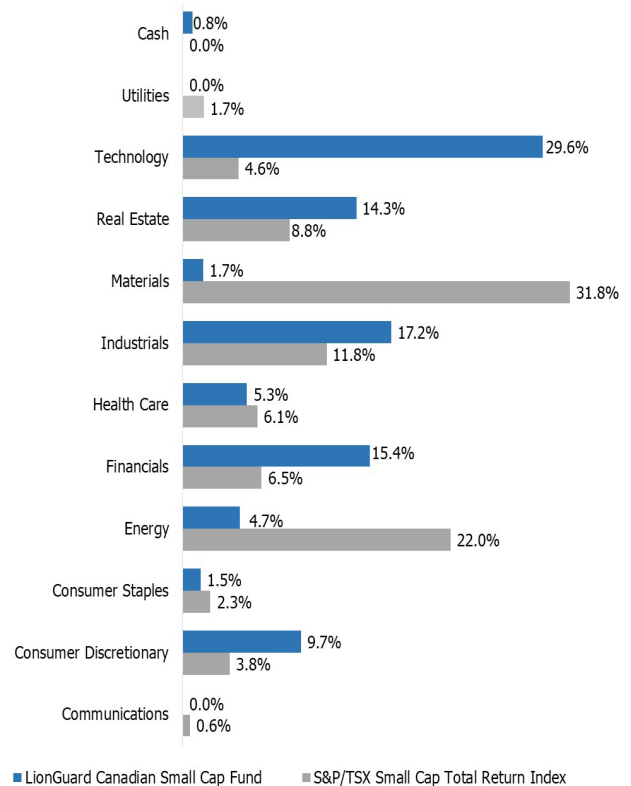
**FUND DESCRIPTION**

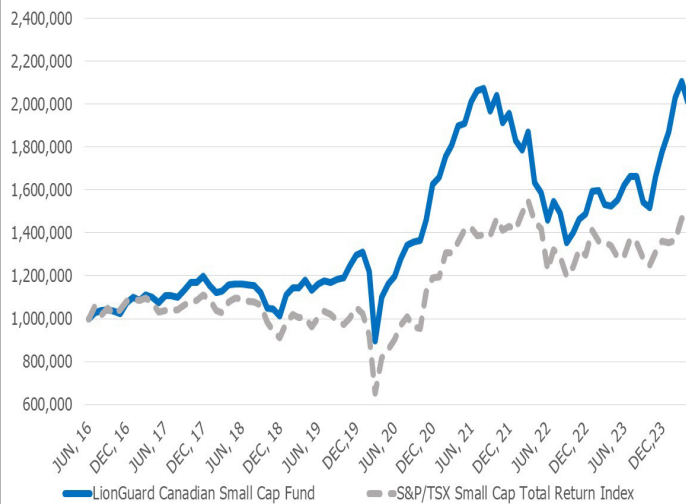

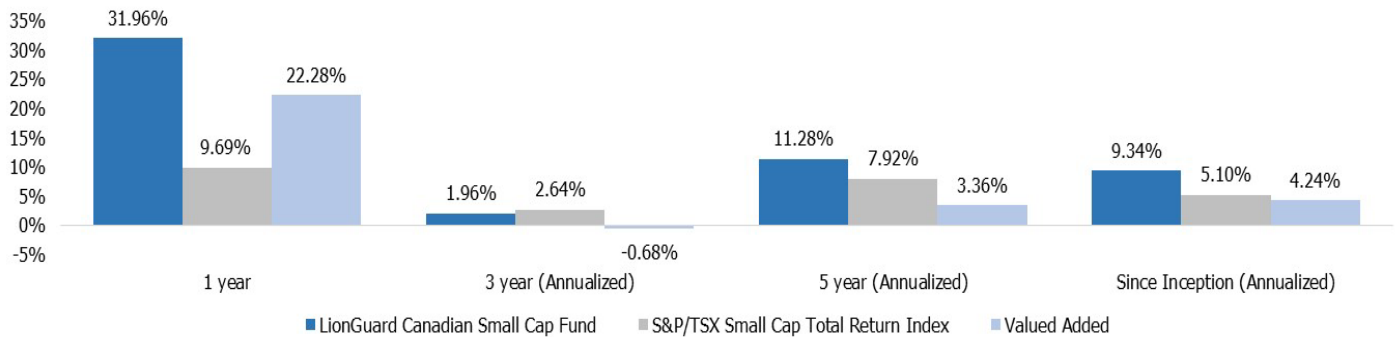
